Rules for Achievement Trial

A team can only enter the trial two times and must stay at the same level (A or B).

A team can enter two different classes (i.e. Beginning Novice and Novice, or Open and Utility)

OR the same class two times (i.e. Open A and Open A again).

If a team enters the same class two times, the first time is considered the "Trial" and this is what is used to determine if the team can Qualify or "Q" (earn placement titles and use to move up into the next class within the club.

There will only be a single long sit/down, even if teams have entered the same class two times.
